What is this product?

Type

The Sub-fund is part of INCOMETRIC FUND, organized under the laws of the Grand Duchy of Luxembourg as a mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 5 years.

Objectives

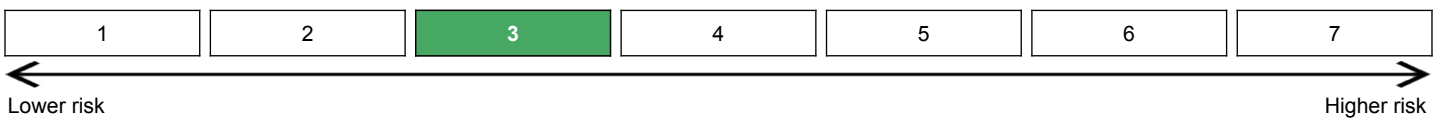
The Sub-Fund is actively managed. The Sub-Fund's investment objective is to provide investors with positive total return through long-term capital appreciation and current income across the market cycle. The Sub-fund utilizes a multi-asset portfolio investment approach, unrelated to benchmark constraints. There can be no assurance that the Sub-Fund will achieve its investment objective and there is no capital guarantee on its assets.

Intended retail investor

Available to all investors and denominated in Euro. The Sub-Fund is designed for investors seeking a balanced portfolio consisting of equities, bonds with no further need to invest in several funds. It targets medium to long term investors and has no time commitment. Minimum Initial Investment: EUR 10,000.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 15/03/2019 and 16/03/2020 (If you exit after 1 year), 16/03/2015 and 16/03/2020 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between 01/04/2021 and 01/04/2022 (If you exit after 1 year), 17/08/2016 and 17/08/2021 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 16/03/2020 and 16/03/2021 (If you exit after 1 year), 11/04/2014 and 11/04/2019 (If you exit after 5 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

Recommended holding period: 5 years

This fund has no minimum holding period, but has been created for long term investment. You should therefore be prepared to remain invested with your investment for at least 5 years. However, you can return your investment on any bank business day in Luxembourg.

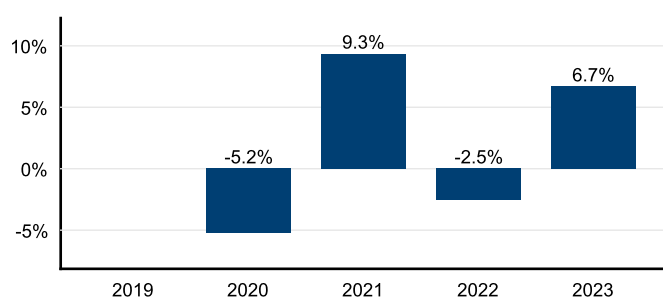
